## PREFACE

States, being spread through American visitors to Wuhan. By 2022 SARS-CoV-2 killed nearly one million Americans within our borders.<sup>3,4</sup>

This is a table from the US Treasury. It shows foreign entities wired into the United States over \$7.7 trillion fake-digital-dollars to buy US Treasury bonds.<sup>9</sup> Look at the December

2021 column. Enemies claim to have wired into the U.S. \$7.7 trillion, but there are only 2 Trillion US Dollars printed and circulating in the entire world. How could this happen? Did they send boatloads of US Dollars to back it up? No they didn't. They just wire the fake-digital-dollars into the United States when they had no real money in their banks to back it up.

**China leads among major economies in the development of a central bank digital currency.**<sup>10</sup>

In other words, China leads the world in creating fake-digital-dollars. According to the US Treasury's Table on page 7, President Xi's bank, which includes the Hong Kong bank, wired into the US Treasury a total of \$1.3 trillion US Dollars to buy US Treasury Bonds. So where is this money? Did it come by boat or by air? No, it's impossible for President Xi to gather up, and then send into the US, \$1.3 trillion US Dollars when there are only \$2 Trillion US Dollars printed and circulating in the entire world. President Xi is flooding the world with his fake-digital-dollars to attack our country, to hurt our families, and to conquer the world.

President Xi and his cronies own and control the People's Bank of China which controls foreign trade and foreign investments in both China and Hong Kong.<sup>11, 12</sup> This one state owned bank controls the flow of all fake-digital-dollars into and out of China. President Xi and his cronies executed a belligerent takeover of this bank from the Central Leading Group on Finance and Economics (CLGFE).<sup>13</sup> He criminally uses this bank's fake-digital-dollars to shore up his stocks and companies in the Chinese stock market<sup>14</sup> and to attack the world.

President Xi, and his cronies, prevent all audits of their criminal companies and criminal banks. They promote technology piracy and steal their technology from the rest of the world using their fake-digital-dollars and hacking.

If any American Company opens up in China, President Xi's bank can, and often will, seize the assets and transfer ownership to President Xi's close friends, on a whim.<sup>16</sup> They simply claim technical espionage and indefinitely imprison the American owners without a trial or any proof.<sup>17</sup> The perfect example of their false imprisonment was in 2015, when President Xi and his cronies carried out a large-scale detention and incarceration of human rights lawyers in China.<sup>18</sup>

***“The supreme art of war is to subdue the enemy without fighting.”*** - Sun Tzu, The Art of War.

Roughly 90% of all world trade is done by sea. President Xi's world conquest, funded by fake-digital-dollars, is designed to be able to cut off the world's shipping of food, fuel, and necessary civilian commodities to any country at any time. An enemy can control or destroy any government simply by cutting off their supply chain of necessities.

President Xi's fake-digital-dollars are obviously being used as weapons of mass destruction in his WW-3 bid for world conquest. In 2008 there were no Chinese banks among the top 10 shipping financial providers in the world. One decade later Chinese banks are rated as the first and second in the world in providing shipping finance.<sup>19</sup> This is a planned attack for world conquest using fake-digital-dollars.

Chinese President Xi's flagship project is called the *Maritime Silk Road Initiative* (MSRI).<sup>20,21</sup> Its goal is to open more markets for Chinese goods, displacing goods and services currently provided by the US and other countries. They have gained control of world shipping using these fake-digital-dollars to buy up and control ships, shipping containers, ports, construction

companies for ports, the port's labor force, and the port's computer / technical equipment. This is a counterfeiting attack to destroy the economy and then own all countries in the world.

President Xi is already trying to destroy our United States by controlling our shipping. A CNBC investigation found that President Xi's shipping carriers rejected U.S. agricultural export containers that were worth hundreds of millions of dollars. They were going to China during the months of October and November in 2020. Instead of shipping our exports to China, they returned empty containers to China while leaving the US agricultural items to rot in our ports.<sup>22</sup> This is what WW-3 cyberwarfare looks like. It is not bullets and tanks. WW-3 is Xi and his cronies withholding food, fuel and necessities from designated enemies like the United States.

President Xi's friends have partial ownership of the Chinese companies that deal in shipping, port construction, port technology, and port labor. So Xi's cohorts passed laws that require all Chinese ports and Chinese corporations to be built to military specifications so that every port and ship can be requisitioned at any time by Xi's military.<sup>23</sup> The People's Liberation Army's (PLA's) Navy inspects and uses these ports regularly. With fake-digital-dollars, Xi pays for fuel, supplies, and management of the military ships from the PLA-Navy while they are in these foreign ports.<sup>24</sup>

President Xi's most powerful weapons in world conquest are his fake-digital-dollars.

- **foreign ports located in over 60 different foreign countries.**<sup>28</sup>
- **the supply chain computers with their Chinese operating systems.**
- **most of the world's shipping containers.**
- **the world's largest ship building company.**
- **the world's largest port construction firms.**
- **the production of the most shipping containers in the world.**
- **the world's largest seafarer workforce.**

**Biden issued an Executive Order<sup>29, 30</sup> on March 9, 2022, that paves the way for the worldwide spread of Xi's illegal fake-digital-dollars:**

US acting President China Joe signed an executive order<sup>31, 32</sup> that will help pave the way for President Xi's fake-digital-dollars. Xi has over one-million, oppressive, military personnel dedicated to hacking US computers and world banks. Thousands of times each day they test for US banking, government and military vulnerabilities. In Chapter 7, you will see Xi used his fake-digital-dollars to buy up the code for banking software companies and the code for the windows operating systems. This makes every world bank and every government agency in America vulnerable.

## **SOLUTION TO THESE FAKE-DIGITAL-DOLLARS**

## Chapter 2

### **Is it time to take our government back when Vice President Joe Biden, and his son Hunter, meet with the Chinese Communist Party and get wired \$1.5 billion dollars in a few days?**

Hunter Biden is Joe Biden's son. Hunter Biden formed his Rosemont Seneca Partners group shortly after Joe Biden was elected Vice President. Hunter mixes funds with his father, paying his father's bills, mortgages, and giving then Vice President Joe Biden half of his income. Hunter Biden and/or Rosemont Seneca Partners paid for contractors at Joe Biden's Delaware home. Hunter also made reimbursements to Joe Biden for a Ford Raptor truck, in an email marked "payment to JRB (Joseph Robinette Biden) from RHB (Robert Hunter Biden) - autopay owasco acct." We must consider that any money that Hunter received went also to Vice President Joe Biden.<sup>36</sup>

On January 3, 2019, Hunter wrote to his daughter Naomi, "I love you," he continued, "But I don't receive any respect and that's fine, I guess. -works for you apparently. I hope you all can do what I did and pay for everything for this entire family for 30 years. It's really hard. But don't worry, unlike Pop I won't make you give me half your salary."<sup>37</sup>

Rosemont Seneca grew quickly and according to an email revealed as part of the Securities and Exchange Commission (SEC) investigation, Rosemont described themselves as "a \$2.4 billion private equity firm co-owned by Hunter Biden and Chris Heinz." <sup>38,39</sup>

Hunter and then Vice President Joe Biden flew to China on Air Force 2 and met with the Chinese Communist Party. Just days later, Hunter received \$1.5 billion for his new Rosemont Seneca Partners, which was later expanded to \$2 billions.<sup>40 41</sup> On the same trip, Hunter also received a 2.8 carat diamond from a Chinese energy tycoon.<sup>42</sup>

Right after Joe Biden was elected VP (2009), Hunter and Joe received a cool \$83,000 monthly salary for Hunter to be a board member for the Ukrainian top natural gas producer, Burisma.<sup>43</sup> Burisma was a company with massive legal problems. These were mostly swept under the rug

after Vice President Biden threatened to withhold US aid to Ukraine. Hunter's salary continued through at least 2015. By 2015 it would have totaled to around \$8 million dollars.<sup>44</sup>

In 2014, Rosemont Seneca received \$112,000 from Burisma. Rosemont then set up an illegal private meeting between the corrupt Burisma and then Vice President Joe Biden.<sup>45</sup> Soon after this meeting, Obama gave \$3 billion US taxpayer's dollars to the Ukrainian government.<sup>46</sup>

A Ukrainian prosecutor started investigating Hunter for "illicit enrichment" along with Burisma's Zlochevsky. Vice President Joe Biden stepped in and threatened the prosecutors saying, "I'm telling you, you're not getting that billion dollars. I'm leaving in six hours. If the prosecutor is not fired, you're not getting the money." Sure enough the prosecutor was fired<sup>47</sup> and the Burisma investigation fizzled out.<sup>48</sup>

Chinese officials have cultivated the Bidens for decades. The Bidens received \$31 million dollars from Chinese businessmen with ties to the highest levels of Chinese Intelligence during and after Joe Biden's tenure as vice president.<sup>49</sup>

Hunter Biden's banking account at Morgan Stanley showed:

- In April 2014. \$142,300 from Kenges Rakishev with ties to the dictator of Kazakhstan, Nursultan Nazarbayev.<sup>50</sup>
- \$1.2 million from an anonymous LLC via a corrupt Swiss bank named BSI, which had \$4.2 billion dollars in irregular transactions and was investigated for money laundering.<sup>51</sup>

In August 2015, \$150,000 was transferred to "MFTCG Holdings LLC Biden". Ownership is

unclear.<sup>52,53</sup>

In December 2013, Hunter and Vice President Joe Biden again flew Air Force Two to China and met with Jonathan Li.<sup>54,55</sup> Ten days later a new Chinese Communist Party Hedge Fund came into existence named BHR. Hunter was put on the board of directors of this Chinese Communist Party fund and given a 10% stake in this billion dollar business for \$400,000 that was loaned to Hunter from the Chinese Communist Party Bank.<sup>56</sup> Professor Steven Kaplan from the University of Chicago's Booth School of Business estimates that Hunter and Joe Biden would make \$20 million on the deal.<sup>57</sup> BHR was later exposed by the FBI for nuclear espionage in the US.<sup>58</sup> BHR partnered with the Aviation Industry corporation of China (AVIC), which is one of China's largest military contractors, and was identified as a major culprit in the theft of US defense technologies.<sup>59</sup> Hunter is still on BHR's board.

The China Entrepreneur Club (CEC) was formed in 2006. Its members are Chinese Communist Party loyalists. In a Senate Hearing, the CEC was identified as the Chinese Communist Party's most elite, government run, hacking organization. This hearing described them as "state-sponsored and supported criminal cartels focused on leveraging cyber-enabled espionage and sabotage." The CEC was listed as one of the greatest threats to US security at this Senate Hearing.<sup>60</sup> On November 5, 2011, Hunter Biden and Devon Archer set up an illegal, off the books, meeting with 30 members of the CEC with then Vice President Joe Biden at the Whitehouse.<sup>61</sup>

The meeting occurred November 14, 2011. These Chinese Communist Party government agents did not register with the Justice Department, as was required by the Foreign Agents Registration Act (FARA). Maggie Cheng, Secretary-General of the CEC, brags in her CEC bio, "The delegation was received with the highest respect and greatest hospitality by the host

countries, marked by meetings held with international political leaders such as U.S. Vice President Joe Biden...<sup>62</sup>

The China Initiative was highly successful under President Trump. ### Chapter 3

#### Is it time to take our government back when twenty Internet commands, from Communist China computers, flipped 5 swing states and the election from Trump to Biden?



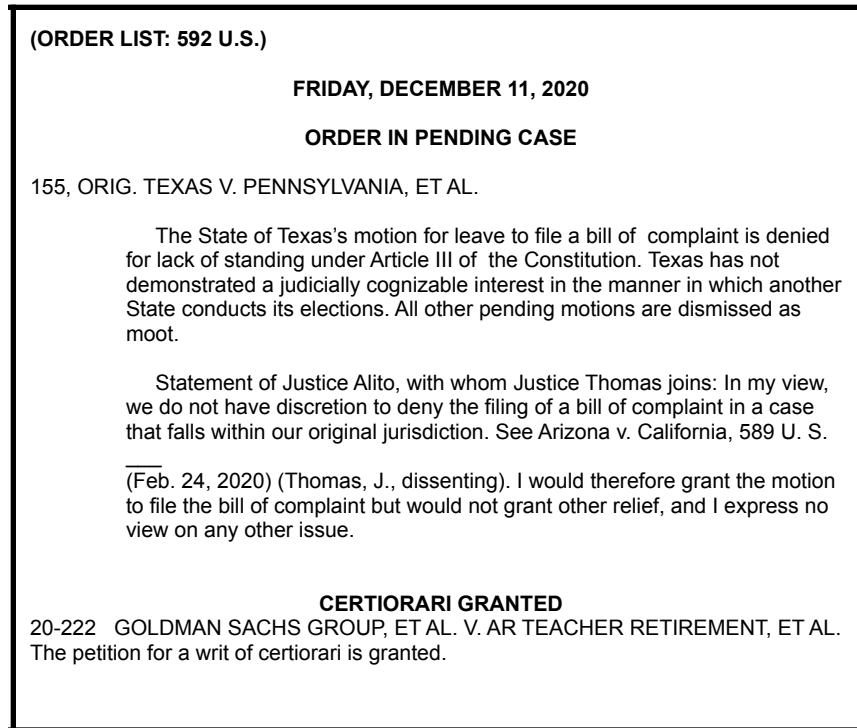

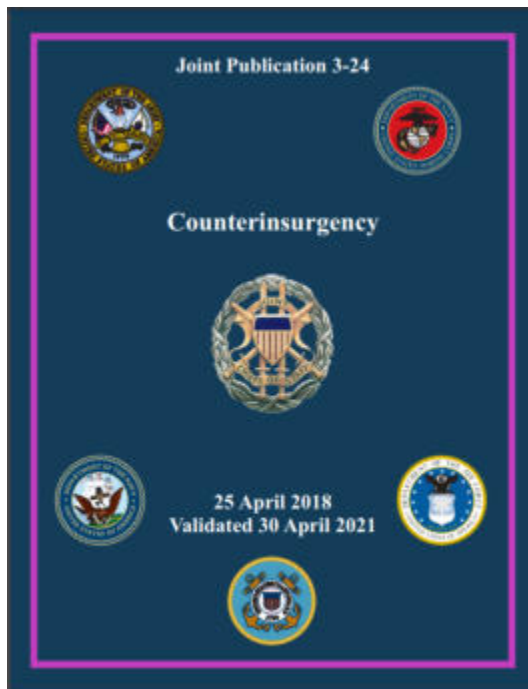
## Chapter 5

The Joint Chiefs of Staff's *Counterinsurgency Manual* was written for this express purpose.

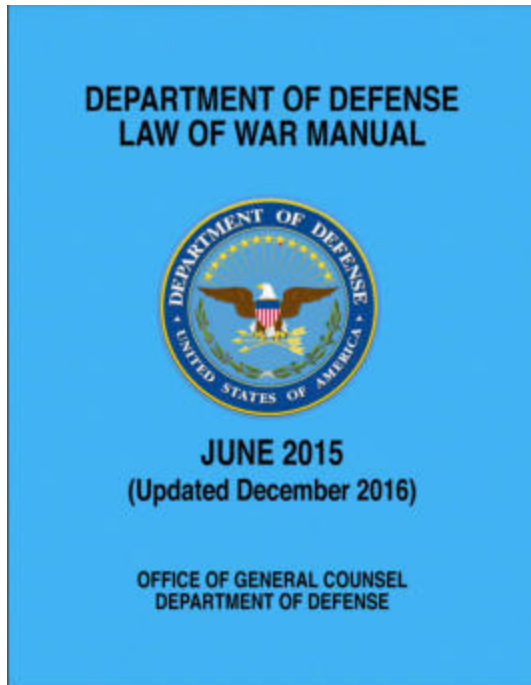

China's colonization of the United States is Xi's primary objective.

**“In the long run, the relationship between China and the United States is one of a life-and-death struggle... Only countries like the United States, Canada and Australia have the vast land to serve our need for mass colonization... Chinese men will outright refuse to marry, or even date, a “tainted” Chinese woman that has ever dated or been romantically involved with a foreign man.<sup>93</sup>

other entities to the reputational, economic, and legal risks of involvement with entities in or linked to Xinjiang and President Xi's human trafficking.

### Is it time to take our government back when enemies destroy our freedom of speech through Internet censorship and Internet canceling of Americans?

**“The central committee believes, as long as we resolve the United States problem with one blow, our domestic problems will all be readily solved. Therefore, our military battle preparation appears to aim at Taiwan, but in fact is aimed at the United States, and the preparation is far beyond the scope of attacking aircraft carriers or satellites.”**

(Chi HaoTian - Vice Chairman of China’s Central Military Commission) <sup>99, 100</sup>

So Xi’s plan is to destroy the United States with one blow. This can only be done with a well programmed Artificial Intelligence (AI) Network. If you look at the computers that were used in the altered US presidential elections, then you will see a small part of Xi’s Artificial Intelligence network.

With his actions, Xi has publicly declared a “one-sided” (asymmetric) WW-3 on the United States.<sup>101, 102, 103</sup> He interfered in our elections and put Biden in as president. He had Biden take down our borders to flood our country with known criminals.<sup>104</sup> The Globalist plan has long been to disarm Americans as well as to defund our police. Xi had Biden try to take our guns, then defund and disarm our police.<sup>105</sup> Xi put over a million of his own men, women, and children, including Americans, into his 1,200 plus concentration camps.

**President Xi is spearheading the invasion of Ukraine.** A federal report by the *US-China Economic and Security Review Commission*<sup>106</sup> stated, “China coordinated a large cyberattack on Ukrainian military and nuclear facilities prior to the Russian ground invasion. The computer network exploitation attacks, designed to steal data or gain intelligence about how to exploit network vulnerabilities and disrupt defense and civilian infrastructure, targeted over 600 websites, including Ukrainian military and government networks. The cyberattacks reportedly

peaked on February 23, on the day before Russia invaded Ukraine.”

Xi is responsible for “Military-Civil Fusion.”<sup>107</sup> Simply put, all technology that is brought into China belongs to the Chinese military.<sup>108</sup> Americans must come to grips with the fact that moving American cyber-technology into China is aiding and abetting enemies of the United States. This is treason.<sup>109</sup>

Xi Jinping, and his cadre, declared that all of their future wars will be cyber-warfare. They said that no future war can be won without cyber-warfare<sup>110</sup> and Artificial Intelligence is necessary for China to take the US “in one blow.” President Xi stated that “without cyber-security, there is no national security.”<sup>111</sup>

The 2019 *Report to Congress of the US-China Economic and Security Review Commission* stated that China has an extremely large, professionalized cyber-espionage military community.<sup>112</sup> According to the US State Department and the Department of Justice, “President Xi is developing and acquiring key technologies through criminal means.”<sup>113</sup> Acquiring this technology is often done by theft, hacking, censorship, and controlling the applications on the Internet. Xi appointed Lu Wei to head his cyber-warfare team, which is in charge of censoring the world's Internet using Xi's cyber-espionage military.<sup>114</sup>

### **Mark Zuckerberg and Facebook:**

- In 2009, China's military blocked Facebook due to protests in its western region of

Xinjiang.<sup>115</sup>

- 2010 to 2014: Mark Zuckerberg apparently spent 4 years studying Mandarin after Facebook was banned by China in 2009.<sup>116</sup>
- On October 22, 2014, Mark Zuckerberg agreed to be on the board of China's premier engineering campus' business school.<sup>117</sup>
- In early December 2014, President Xi's head of cyber-terrorism and Internet-censorship, Lu Wei, went to Facebook's California headquarters in Menlo Park. Lu Wei was the former deputy head of the "*Propaganda Department of the Chinese Communist Party*" and now heads China's "*Central Leading Group for Internet Security and Information.*"
- On Wednesday, September 23, 2015, at the Microsoft headquarters outside of Seattle, Xi met with Mark Zuckerberg. Mark Zuckerberg spoke to Xi in fluent Mandarin.<sup>118</sup>
- On Friday, September 25, 2015, Mark Zuckerberg again met with Xi at a State Dinner held at the White House.<sup>119</sup> At this meeting, speaking to Xi in fluent Mandarin, Mark Zuckerberg asked Xi to give Zuckerberg and his Chinese wife's unborn first child his Chinese name.<sup>120</sup> Zuckerberg's wife was in her 7-month of pregnancy.
- One month later, in October 2015, Zuckerberg went to Beijing to once again to pitch Facebook to Xi and his military cyber-terrorists. Zuckerberg posted a picture of himself on Facebook, jogging in lung crippling smog with the caption, "It's great to be back in Beijing."
- Each year, Facebook sells more than \$5 billion dollars worth of advertising to China's cyber-espionage military community through military co-owned corporations.<sup>121</sup>
- In 2016, Mark Zuckerberg created new censorship software. This software was to be sold to the cyber-espionage military community. This software would prevent posts from appearing in certain geographical areas. Facebook then blocked roughly 55,000 pieces of content in about 20 countries between July 2015 and December 2015.<sup>122</sup>

- In 2020 Mark Zuckerberg spent \$400 million dollars to get Biden elected, by supplying fraud-friendly drop boxes in Biden supporting neighborhoods.<sup>123</sup>
- **January 7, 2021 at 8:05 AM PT: Zuckerberg personally blocked President Trump from both Facebook and Instagram. He cited that the risks are simply too great to allow President Trump to continue to use their services.**<sup>124,125</sup>

## MICROSOFT AND BILL GATES:

- In 1997 China instituted the “Great Firewall.” China’s censoring was in full practice.<sup>126</sup>
- In 2005, Bill Gates launched a blogging software program called *MSN Spaces* in China. CEO Bill Gates admitted that they censored according to the directions of the Chinese military. Words censored by Bill Gates on *MSN Spaces* were, “democracy,” “human rights,” “freedom of expression.” Bill Gates also blocked searches for the words, “Tibet independence,” “Falun Gong,” and “Tiananmen Square.”<sup>127</sup>
- April 18, 2006, the then Chinese President Hu Jintao visited Microsoft’s campus in Redmond, Washington and had dinner at the home of Bill Gates, Microsoft’s chairman and chief software architect.<sup>128</sup>
- 100,000 words were studied to apply censorship and surveillance programs to Bill Gates’ products like SKYPE.<sup>129</sup>
- President Xi’s cyber-espionage military community has censored and surveilled all Skype users since 2008.<sup>130</sup>
- In 2008, Bill Gates lied to Stanford Students and told them that no one could censor the Internet even though he had been censoring and helping the Chinese cyber-espionage military community since 2005.<sup>131</sup>

- In 2010, Dr. Kai-Fu Lee, founded *Microsoft Research Asia* in Beijing, China which is working directly with the criminal Chinese cyber-espionage military community.<sup>132</sup>
- On December 5, 2011, Bill Gates shared sensitive research information on a next generation nuclear reactor with China's cyber-espionage military community at the *Chinese National Nuclear Corporation*.<sup>133</sup>
- On September 23, 2015, at the Microsoft headquarters, Xi met with Bill Gates and the Microsoft team.<sup>134</sup> He also met privately with Bill and Melinda Gates.<sup>135</sup>
  - At this meeting Microsoft reported to Xi that Microsoft had a presence in China for more than 20 years (since 1995), which now includes the company's largest R&D facility outside the United States (**2010 - Microsoft Research Asia in Beijing, China**).<sup>136</sup> This is co-owned by Xi's cyber-espionage military community.
  - During the visit, Harry Shum, Microsoft executive vice president of Technology and Research, showed Xi a showcase of innovative Windows 10 devices enabled by Microsoft's investment in the "**China Technology Ecosystem**" in Shenzhen.<sup>137</sup> This means that it was all censored and surveillance enabled if it came from the "**China Technology Ecosystem**" in Shenzhen.<sup>138</sup>
  - Microsoft announced in recent days a number of **new partnerships** with Chinese customers and partners, including **UniGroup, Baidu, CETC, Xiaomi, Shanghai Media Group, the Sichuan province and the Xi'xian New Area**, a special development zone.
  - Microsoft donated \$40 million dollars to establish a Xi controlled Chinese research university on American soil. It was named **Global Innovation Exchange, or GIX**.<sup>139</sup>

- On Friday, September 25, 2015, Mr. Satya Nadella, CEO of Microsoft again met with Xi at a State Dinner held at the White House.<sup>140</sup>
- On December 18, 2015, Bill Gates partnered with **China Electronics Technology Group Corporation (CETC)**, which designed the electronic guts for China's first nuclear bomb and designs China's guided missiles and satellites.<sup>141</sup> to form a new company named **C&M Information Technologies** (CETC & Microsoft Information Technologies).<sup>142</sup>
- On March 28, 2016, Bill Gates designed and sold a censorable and surveillable version of Windows 10 to the Chinese cyber-espionage military community.<sup>143</sup>
- June 6, 2018, Bill Gates programmers, at the cyber-espionage controlled *Microsoft Research in Beijing China*, worked with the *University of Defense Technology in Changsha China*. They were refining word searching techniques for the Chinese military's Artificial Intelligence (AI) surveillance and censorship programs. These augmented the recent attacks on Ukraine.<sup>144</sup>
- On July 21, 2018, through *Microsoft Research in Beijing, China*, Microsoft worked with the Chinese cyber-espionage military community's university, *The National University of Defense Technology in Changsha, China* to develop facial recognition code for future AI weaponry to be used for surveillance and censorship through facial recognition.<sup>145</sup>
- On November 15, 2018, Microsoft teamed up with the criminal Chinese military to develop Artificial Intelligence code (AI) that will answer questions about future targeted citizens to be used in surveillance, censorship, arrests and slavery.<sup>146</sup>
- In 2019 Microsoft worked directly with the cyber-espionage military community at their

university, "*China's National University of Defense Technology*."<sup>147</sup>

- As of June 4, 2021, Microsoft's Chinese illegal military censoring is now in the United States, Germany, Singapore, France and Switzerland. A search for "Tank Man," on the Bing search engine, did not display any image results. The apparent censorship came on the anniversary of China's violent crackdown on protests in Tiananmen Square in 1989.<sup>148</sup>
- On June 4, 2021, DuckDuckGo was also censored. DuckDuckGo licenses its search engine results from Microsoft.<sup>149</sup>

### GOOGLE'S INVOLVEMENT:

- In 2002, Google's search engine had 25 percent of the Chinese searches. The Great Firewall would cut Chinese users' connections for several minutes if a banned term were searched, making it appear as if Google were having problems.<sup>150</sup>
- In 2006 a censored Chinese version of Google began to operate in China. (www.Google.cn).<sup>151</sup>
- In 2010, Google claimed it was leaving China but was still present through 2020.<sup>152</sup>
- In 2017, Google announced it is creating an Artificial Intelligence (AI censorship) facility in Beijing, China with direct military connections.<sup>153, 154</sup>
- On June 1, 2018, Google refused to work with the US military any longer.<sup>155</sup>
- In 2018, Google has engineers designing warfare search software that would leave out content blacklisted by the Chinese military.<sup>156</sup> This was a military weapon to be used for censorship, surveillance, and detention of Chinese and American citizens.
- In 2018, Google announced that it will fund Artificial Intelligence (AI) research in the military Chinese *Tsinghua University*, which is a key national defense lab located at the

*“High-End Laboratory for Military Intelligence.”*<sup>157</sup>

- In June 2018, Google signed another joint artificial Intelligence research agreement with Fudan University, which is under military control through Fudan’s *“Military Projects R&D Office.”*<sup>158</sup>
- On October 9, 2018 (concerning the 2016 election) it was proven that Google’s search engine blocked results for searches for President Trump in the 2016 Presidential Election, but allowed anything searched for Hillary to be displayed in the searches.<sup>159</sup>
- March 14, 2019, Marine Gen. Joseph Dunford, the chairman of the Joint Chiefs of Staff, said that the work that Google is doing in China is directly benefiting the Chinese military.<sup>160</sup>
- In a 2019 book, it was reported that cofounder Larry Page and CEO Eric Schmidt, made the decision to supply Google search engine’s censoring code to China for their cyber-espionage military community’s censoring. To comply with China’s Great Firewall, they programmed computers within China to search for millions of websites and when they found one that was blocked by the Great Firewall, they would prevent it from showing up in Google’s search engines.<sup>161</sup>
- In March of 2019, Google refused to continue to work with the US military on Project Maven. The Project Maven contract with Google ended in March 2019. Project Maven is a program that uses artificial intelligence to analyze aerial imagery taken from military drones.<sup>162</sup>
- On June 2, 2019, an article on Artificial Intelligence facial recognition was written by Google and the cyber-espionage military community’s *“National University of Defense Technology.”*<sup>163</sup> It was written by Naiyang Guan at Xi’s *National University of Defense Technology* and Yangmuzi Zhang with Google.
- On June 3, 2019, the House Judiciary’s Subcommittee on Antitrusts held a bipartisan

investigation into Google's competition in digital markets.<sup>164</sup> Here is the full 450 page report.<sup>165</sup>

- In October 2019, Google refused to work with the US Military and withdrew their \$10 billion contract bid to the Pentagon for a cloud computing project called Joint Enterprise Defense Infrastructure (JEDI), which would migrate significant amounts of Pentagon data to the cloud. Microsoft, Oracle, and Amazon were said to be vying for the contract, but all of these companies are heavily involved with the Chinese military and none of these companies are safe for the US military.<sup>166</sup>
- Around June 1, 2020, YouTube, a Google subsidiary, disclosed that its algorithm had automatically removed certain phrases criticizing the Communist Party of China. Censored terms were "communist bandit," which is derogatory for the Chinese Communist Party, or the name of their for the Chinese Communist Party's paid Internet trolls, which is the "50-cent party."<sup>167, 168</sup>
- In early June 2020, Google censored and removed a mobile application from its Google Play Store that helped users locate and delete apps developed by Chinese-based companies that might be a security risk. The app, "Remove China Apps," was developed by Indian firm *OneTouch AppLabs*. It gained popularity due to growing anti-China sentiment in India since the first battle of what is now a serious security situation at the Himalayan border region between the two countries.<sup>169</sup> At least 20 Indian soldiers died in the border skirmish.<sup>170</sup>
- On October 21, 2020, the Trump administration sued Google in what is the largest antitrust case against a tech company in more than two decades. Eleven states joined in. The eleven states included: Arkansas, Florida, Georgia, Indiana, Kentucky, Louisiana, Mississippi, Missouri, Montana, South Carolina and Texas.<sup>171</sup>

Covid-19 is a disease that is caused by the SARS-CoV-2 virus.

Biological warfare is the use of bacteria, viruses, or toxins to destroy men and animals or food. **Altering a virus through gain-of-function manipulation, to attack humans, is creating a bioweapon.** The 1972 Biological Weapons Convention (BWC)<sup>184</sup> **bans the development, production, acquisition, transfer, stockpiling, or use of biological weapons.** China, along with all members of the United Nations are signatories on the 1972 Biological Weapons Convention. Any biological weapon that can kill or bring significant harm to numerous individuals is designated as a **weapon of mass destruction (WMD).**

**The Wuhan Institute of Virology was built by a contractor for the People’s Liberation Army under strict secrecy. This top-security military laboratory for handling deadly human pathogens was unveiled in 2017.<sup>185</sup> As we proved earlier, Xi’s military owns an interest in all companies that operate in China. 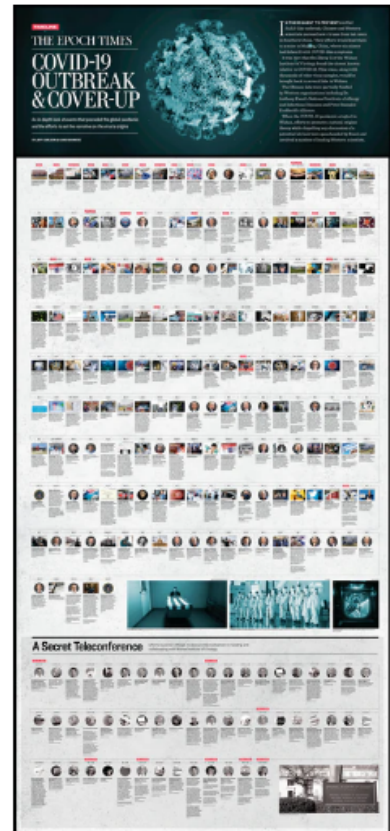

I will summarize what I thought were the most important facts.

**2004 - Shi Zheng-Li**, a director of the *Wuhan Institute of Virology* discovers a natural reservoir of coronaviruses in bats living in caves in southern China.

**Dec. 12, 2007** - Director Shi Zheng-Li published a paper in the *Journal of Virology* that shows how the horseshoe bat viruses can be manipulated to infect and attack humans.

**Sept. 2008** - Peter Daszak's EcoHealth Alliance receives a grant from NIAID to study a pool of bat corona viruses that have not yet emerged in humans.<sup>187</sup> In a Nov. 2021 Senate hearing, Senator Rand Paul, when questioning Fauci, said to Fauci, "The *NIH* did fund gain-of-function research in Wuhan. EcoHealth Alliance took the virus SAC014 and combined it with WIV1 and caused a recombinant virus that doesn't exist in nature and it made mice sicker, mice that had human eye cells."



**2011** - Construction begins on the new building for the Wuhan Institute of Virology.

**Dec. 30, 2011** - An article in the *Washington Post* shows researchers developed a laboratory virus that does not exist in nature. This is gain-of-function research. The authors were:

1. Dr. Anthony Fauci - Director of the *National Institute of Allergy and Infectious Diseases (NIAIDS)*
2. Gary Nabel - also from National Institute of Allergy and Infectious Diseases (NIAIDS)
3. Francis Collins - director of the National Institute of Health (NIH)

**April 2012** - Six miners, from a Mojiang Region mine in the Yunnan Province, fall ill from a bat virus. The virus is isolated from the mine by director Shi Zheng-Li's team and is transported to the Wuhan Institute of Virology. It was originally named RaBtCoV/4991. The virus was later

renamed RaTG13 and is the closest known relative to the Sars-CoV-2 virus. RaTG13 is the most lethal bat coronavirus known to man with a 50% kill rate. It is a 96.2 genetic match with the SARS-CoV-2 virus.<sup>188</sup>

**April 26, 2012** - Fauci tells a *Senate Homeland Security Committee* hearing that he is funding gain-of-function research that allows for airborne transmission, from human to human, of the modified virus that received gain-of-function.

**May 2012** - Two of the miners from the Mojiang Mine die. The other four surviving miners had antibodies against a SARS like coronavirus. A third miner dies of the RaTG13 virus. This virus now has killed 50% of the humans that were exposed to it. This is the most lethal bat coronavirus that the Wuhan bioweapons found. It is the basis for the man-made SARS-CoV-2 virus that was unleashed on the world.

**June 22, 2012** - *NIAID* financed a study that genetically modified an avian influenza virus to make it airborne from person to person. It was reported in the journal Science.

**July 31, 2012** - Fauci defends gain-of-function research in a talk titled, “*The Way Forward in Influenza research*.”

**2013 to 2020** - The US *Department of Defense* gives Daszak’s *EcoHealth Alliance* \$39 million over a period of eight years for his gain-of-function research.

**Feb. 7, 2013** - The journal *PLOS Pathogens* published an article on “new forms of bat viruses” which was written by Tian who worked at the Wuhan Center for Disease Control and Prevention Bio-Safety Level 2 Lab (later located 900 feet from the Huanan Seafood Market, which reportedly housed 605 diseased bats). The Level 2 Lab should never be studying dangerous coronaviruses. Only a Level 4 Lab, with properly trained personnel should be working on deadly pathogens with the sole purpose of cure or prevention.

**July 24, 2013** - Director Shi Zheng-Li identified the genome as the RaBtCov/4991 virus, (later renamed RaTG13 virus) which was collected from the Mojiang mine where the three miners died. This is a serious pathogen that killed 50% of the miners infected. This is also the closest related virus to SARS-CoV-2 virus that was released into the world.<sup>189</sup>

**July 24, 2013 was a very important turning point in President Xi's two Wuhan bioweapons research and development labs.** They now had everything they needed to make the SARS-CoV-2 virus and unleash it on their perceived enemies. They had 6 years to develop the new weapon of mass destruction before its release.

1. President Xi's bioweapons labs in Wuhan now had the Mojiang mine's bat virus **RaBtCov/4991 (later renamed to RaTG13)**, which allegedly was used to make SARS-CoV-2 virus. It was the most deadly bat virus that the weapons lab recorded. It killed 50% of those miners that were exposed.
2. They now had Director Shi's **December 12, 2007 gain-of-function genetic modification research that can make any virus more contagious to humans.**
3. They now had Fauci's *NAIAD* financed **2012 gain-of-function genetic modification research, which makes any virus capable of airborne transmission from human-to-human.**
4. On **September 12, 2019**, just before the release of SARS-CoV-2 virus into the world, someone in Director Shi's office took down the *Wuhan Institute of Virology's Viral Sequencing Database*. This was an open genetic database where all of the weapons lab's experimentation was recorded.
5. In **October 2019**, there was an increase in traffic in all Wuhan hospitals. A later Harvard Medical School study suggested that this was the start of the COVID-19 outbreak, which was caused by the release of the SARS-CoV-2 virus.
6. On **February 3, 2020**, just after the release of SARS-CoV-2 virus on the world, Director Shi authored a paper that hid the database name of the Mojiang mine's bat virus, by renaming **RaBtCov/4991 virus to the RaTG13 virus.**

**June 1, 2014** - Daszak's *EcoHealth Alliance* receives a \$3.7 million dollar grant from Fauci's *NAIAD* to study if a bat coronavirus could be transmitted to humans. The *NIH* later admitted to funding the *EcoHealth Alliance's* gain-of-function research.<sup>190</sup>

**October 16, 2014** - President Obama announced a moratorium on all gain-of-function research.

**2015** - The French Level 4 Certifying Firm pulled out of the Xi's military owned *Wuhan Institute of Technology's* bioweapons lab and refused to supply the institute with deadly viruses or antivirus suits.

**2015 and after** - Director Shi and her team produce numerous articles about their gain-of-function research.

**January 9, 2017** - Obama lifts the moratorium on gain-of-function research after close to 3 years.

**September 12, 2019** - *The Wuhan Institute of Virology's Database of Viral Sequencing* is taken offline in the middle of the night. This was the month before there was a surge of patients at all of the Wuhan hospitals.

**The month of October, 2019** - A *Harvard Medical School* study documents an increase in traffic in all of the Wuhan hospitals. They suggest that October was the beginning of the pandemic.

**November 17, 2019** - The first case of documented COVID-19 disease, from the Sars-CoV-2 virus, was reported by the *South China Morning Post*.

**December 1, 2019** - The *Lancet* would later claim that this was the first date for a case of COVID-19 disease that is caused by the SARS-CoV-2 virus.

**December 2, 2019** - *Xi's bioweapon lab, the Level 2 Wuhan Center for Disease Control and Prevention Laboratory, was finally officially opened at a location within 900 feet of the Huanan Seafood Market.* It was reported to house 605 diseased bats and other diseased animals. Tian and virologist Edward Holmes wrote in 2013 that they were studying new types of bat coronaviruses at the *Level 2 Wuhan Center for Disease Control and Prevention Laboratory*. This should never be done in any Level 2 laboratory.

**December 8, 2019** - The *World Health Organization* claimed that this was the first date of the COVID-19 disease, which is caused by the SARS-CoV-2 virus.

**December 27, 2019** - Xi has the full genetic sequence of the SARS-CoV-2 biological warfare virus that causes COVID-19, but he hides it from the world who are experiencing the COVID-19 pandemic and need to develop a vaccine using the genetic sequence.

**December 31, 2019** - There were 59 suspected cases of Covid-19 transferred to one Wuhan hospital.

**January 5, 2020** - Virologist **Edward Holmes**, from the *Level 2 Wuhan Center for Disease Control and Prevention Laboratory*, admitted to having the full genetic sequence of SARS-CoV-2. He claims that he did not release it because of pressure from the Chinese authorities. Edward Holmes also had the genetic code for the RaBtCov/4991 (later renamed to RaTG13), which was a 96.2% genetic match to SARS-CoV-2.<sup>191</sup> Yet, months later, on March 17, 2020 he published a paper, *The proximal origin of SARS-CoV-2*, fictitiously claiming that

SARS-CoV-2 came from wildlife.<sup>192</sup>

**April 19, 2020 - A Nobel Prize winner for discovering the HIV virus, Luc Montagnier, backed by two other scientists, proved that the SARS-CoV-2 was man made.** They identified that it was made from the most lethal bat coronavirus RaBtCov/4991 virus, (later renamed RaTG13 virus), which killed 50% of the minors exposed. This virus was combined with the AIDs virus, and the malaria parasite to make the most devastating pandemic in history. **This combination can not happen in nature. Therefore the SARS-CoV-2 was man made.**

**April 24, 2020 - Trump cancels Daszak's *EcoHealth Laboratory* grant for gain-in-function research in the Wuhan Bioweapons Lab.**

**August 27, 2020 - Fauci awarded a new, larger grant to Daszak for gain-of-function research. He also awarded new grants to Kristian G. Andersen for gain-of-function research. On March 17, 2020, Kristian G. 

**attributed to COVID.”**<sup>202</sup> said Dr. Peter McCullough, MD, MPH, who has broadly published on a range of topics in medicine with more than 1000 publications and over 600 citations in the National Library of Medicine.<sup>203</sup>

3. The most current publication was updated February 2, 2022, “*A Guide to Home-Based COVID Treatment - Step-By-Step Doctors’ Plan That Could Save Your Life.*” It was published by the *American Association of Physicians and Surgeons*. It was written by Jane Orient MD & Peter A McCullough MD MPH, and was last updated 2/2/2022.<sup>207</sup>

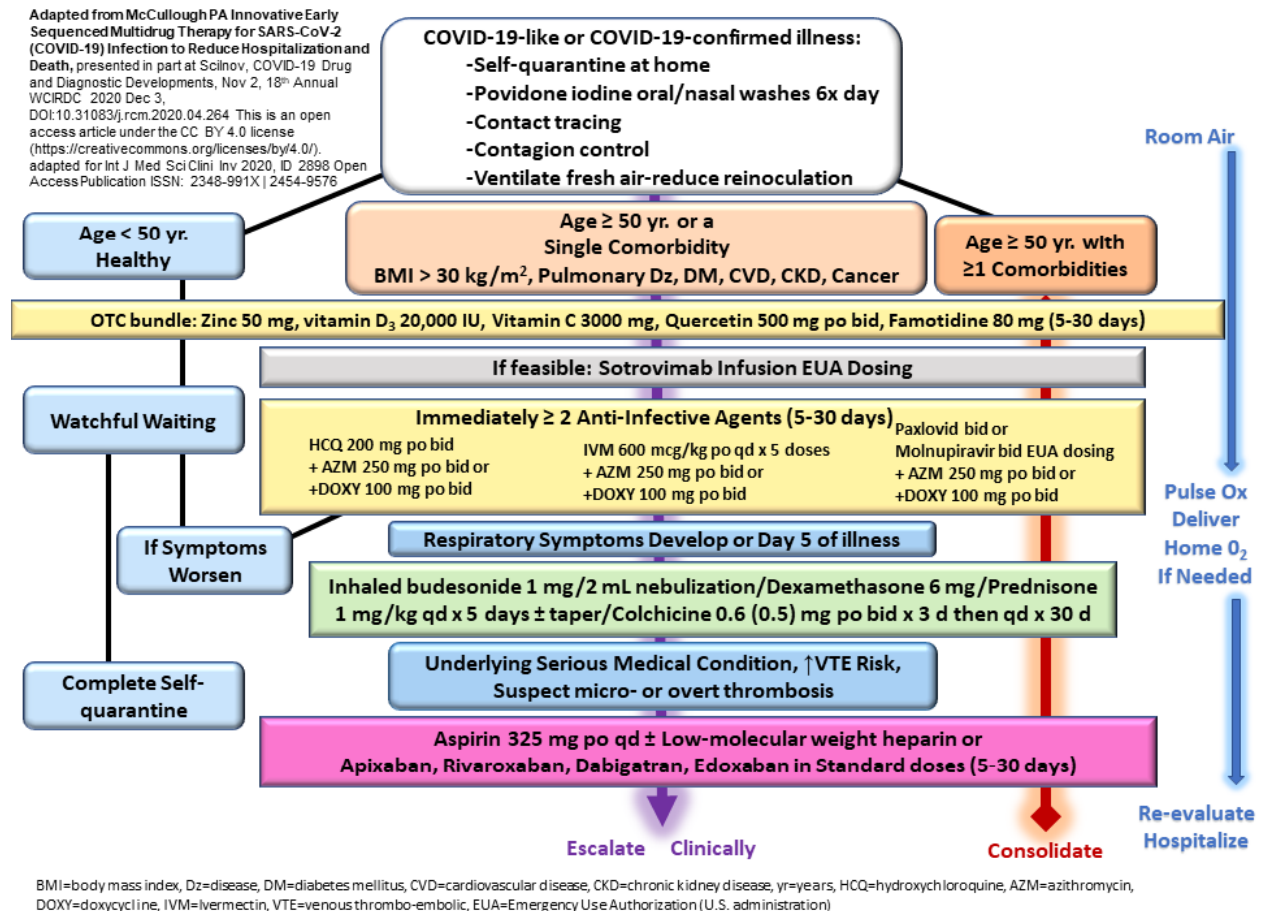

The article '*Proximal Origin of SARS-CoV-2*,'<sup>212</sup> purposely protected the Xi's Wuhan biological weapons lab's actions. It prevented physicians from knowing the origin and the treatment for SARS-CoV-2. It hid the criminal creation of weapons of mass destruction from the people who were dying from them. The authors Kristian G. Andersen, Andrew Rambaut, W. Ian Lipkin, Edward C. Holmes and Robert F. Garry, were all directed and funded by Anthony Fauci and Jeremy Farrar.<sup>213</sup> They are all responsible for killing almost one-million Americans.

Peter Daszak, President of *Eco Alliance*, illegally worked for the illegal Wuhan biological weapons laboratories for well over two decades.

- In 2008 Daszak got his first grant from Fauci to study the bat's viruses in the Wuhan

bioweapons laboratory.<sup>214</sup>

- February 19, 2020, Daszak orchestrated a letter to *The Lancet*. It was co-signed by 26 scientists that were every one linked to the Wuhan biological weapons laboratories. The letter claimed that SARS-CoV-2 virus was found in nature through wildlife. Daszak also condemned, as conspiracy theories, that SARS-Cov-2 was not natural and instead was man-made. Daszak called these “conspiracy theories” that do nothing but create fear, rumor, and prejudice.<sup>215</sup>
- April 24, 2020 - Trump terminated Daszak’s grants from Fauci.<sup>216</sup>
- August 27, 2020 - three days later, Fauci awarded Daszak a much larger grant.<sup>217</sup>
- February 9, 2021 - Daszak made comments to reporters, stating that the *Huanan Seafood Market* was the source of the virus.<sup>218</sup>

Daszak willingly helped kill almost a million Americans by working with the Wuhan biological weapons lab and covering up their criminal involvement and his. He misled Americans about the origin and therefore the cure for the SARS-CoV-2 virus.



## Chapter 11

Hitler, Stalin, Castro, and Mussolini all seized upon gun laws to punish, incarcerate, and exterminate their opponents, while permitting their own evil cliques to expand and strengthen the state and party monopolies with their gun ownership.<sup>224</sup> Biden openly boasted to our enemies, including Xi and his cyber-espionage military community, that he will work outside of Congress's lawmaking abilities to control our guns. He did this through two White House briefings on the same day.

**On April 7, 2021 the White House briefing room announced that Biden will work outside of Congress to make gun control laws by issuing billions of dollars in grants to communities and organizations who demonstrate support for gun control.**<sup>225</sup>

- The Justice Department, within 30 days, will issue a proposed rule to help stop the proliferation of “ghost guns.”
- The Justice Department, within 60 days, will issue a proposed rule to make clear when a device marketed as a stabilizing brace effectively turns a pistol into a short-barreled rifle subject to the requirements of the National Firearms Act.
- The Justice Department, within 60 days, will publish model “red flag” legislation for states.
- To fund gun control, the Administration is investing in evidence-based “**Community Violence Interventions**” (CVI). **This is simply renaming “Gun Control” to “Community Violence Intervention.”**
  - The American Jobs Plan proposes a \$5 billion investment over eight years.
  - The Department of Health and Human Services is organizing a webinar and toolkit to educate states on how they can use Medicaid.
  - Five federal agencies are making changes to 26 different programs.<sup>226</sup>
- The Justice Department will issue an annual report on firearms trafficking.
- The President will nominate David Chipman to serve as Director of the Bureau of Alcohol, Tobacco, and Firearms.

On April 7, 2021 the White House briefing room announced that Biden, acting outside of Congress, will invest billions more of US taxpayer dollars in Community gun control, through grants and awards than were first announced above on April 7, 2021.<sup>227</sup> These gun control grants are renamed “Community Violence Intervention (CVI).”

**The Department of Justice will redirect over \$1 billion of taxpayer dollars in grants for gun control:**

- The DOJ, in its FY21 *Edward Byrne Memorial Justice Assistance Grant* (JAG) program, will award \$484 million in grants for gun control on September 30, 2021.
- The DOJ, in its \$18.9 million *Byrne Criminal Justice Innovation* (BCJI) program, will award \$18.9 million in grants for gun control.
- The DOJ will make gun control a priority focus area in its FY21 *Cops Hiring Program*, a \$156 million competitive grant program, that will be awarded on September 30, 2021.
- The DOJ will give priority to applicants, who propose gun control strategies, will award \$8 million in grants in the FY21 *Smart Policing* program, which will be awarded on September 30, 2021.
- The DOJ issued guidance to clarify that community-based organizations, with gun control proposals, are eligible for the \$12.75 million *Second Chance Act Community-Based Reentry Program*. This grant program was posted January 14, 2021.
- The DOJ will make it clear to all judicial districts that they can support gun control programs through their *Project Safe Neighborhoods* (PSN) grants program. Grant requests were posted on May 3rd 2021.
- The DOJ will support gun control through its FY21 *Strategies to Support Children Exposed to Violence* program, a \$7 million grants gun control program which will be awarded September 30, 2021.
- The DOJ will give priority to gun control applicants, in its \$11 million *Comprehensive Youth Violence Prevention and Reductions Programs*. The awards will be made by September 30, 2021.
- The DOJ will continue to promote gun control via webinars and training through the *National Gang Center*.
- The DOJ will support gun control in its FY21 School Violence Prevention Program (SVPP), a \$53 million competitive grant program that funds equipment, technology, and training to address gun control. Awards will be made by September 30, 2021.
- The DOJ will support gun control through its FY21 *Hospital-Based Victim Services* program. This is \$2 million in grants for programs that link the victim services field and medical facilities. The awards will be made by September 30, 2021.
- The DOJ will support gun control through the *Office for Victims of Crime’s (OVC) new Center for Culturally Responsive Victim Services* program, which will provide \$3 million in grants. The award will be made by September 30, 2021.
- The DOJ OVC will announce that over \$1 billion dollars going to the Victims of Crime Act

(VOCA) can be used by any state for gun control efforts.

**The Department of Health and Human Services will direct \$52.5 million more taxpayer dollars to gun control:**

- The *National Institutes of Health* (NIH) will provide \$12.5 million in gun control grants. Awards expected in September 2021.
- The *Centers for Disease Control and Prevention* (CDC) will fund \$10 million over 5 years for gun control. Awards are expected by August 2021.
- The *Centers for Disease Control and Prevention* (CDC) will provide \$30 million over 5 years, through its *National Centers of Excellence in Youth Violence Prevention* (*Youth Violence Prevention Centers* or *YVPCs*) program. Awards expected in Sept., 2021.

**The Department of Housing and Urban Development (HUD) will redirect \$8.6 billion more of taxpayer dollars to gun control:**

- HUD will encourage gun control through \$200 million in grants for the *FY21 Choice Neighborhoods Initiative*.
- HUD will encourage gun control through its \$5 billion *CARES Act, Community Development Block Grant - CV Funds* (CDBG-CV).
- HUD will publish a guide by June that explains how gun control activities can use CDBG funds, which will also apply to annual formula CDBG funds, of approximately \$3.4 billion per year.

**The Department of Education (ED) will redirect over \$2.5 billion to support gun control actions.**

- The ED will issue guidance on how \$1.6 billion in taxpayer dollars can promote gun control through their *21st Century Learning Centers* (21st CCLC). New awards will be made July 1, 2021.
- The ED will support states and school districts in investing \$1.22 billion in gun control through the *Student Support and Academic Enrichment* (SSAE) program. New awards will be made July 1, 2021.
- The ED will launch a new competition in FY22 for *Project Prevent*, an \$11 million in grants for gun control.
- The ED will incentivize applicants to use gun control strategies in two grant competitions for FY22: The grants will go to the *Full Service Community Schools* and *Promise Neighborhoods*.

**The Department of Labor (DOL) will promote gun control with \$3.75 billion dollars in grants.**

The DOL will issue \$3.5 billion in grants under its *Workforce Innovation and Opportunity Act* (WIOA) programs, encouraging grantees to incorporate gun control.

- The DOL will provide \$89 million to promote gun control through YouthBuild, a WIOA discretionary program.
- The DOL will give \$25 million for gun control grants through allowable grant activity for its Young Adult Reentry Partnership grants. The funding opportunity announcement will be posted in early 2022.

## Chapter 12

### Is it time to take our government back when enemies destroy our borders and fund riots in the streets?

We established in Chapter 10 that the co-founder of the official Black Lives Matter group, Alicia Garza, gets her donations from Xi's cyber-espionage military community.

The Communist Manifesto says that to bring Communism in, you must have a bloody revolution.<sup>228</sup> Mussolini created his blackshirts that turned protests into violent riots. Hitler had his brown shirts to turn peaceful protests into violent riots. Xi has his ANTIFA to turn peaceful protests into riots.

According to the ANTI-Fascist Handbook by Mark Bray,<sup>229</sup> the ANTIFA support both anarchy and marxism.<sup>230</sup> Marxism<sup>231</sup> is a three step transition. The first transition step in Marxism is to destroy the existing government through violence and bloody revolution, intimidating the people and creating fear while destroying the morality of the citizens so that they won't unite and fight back. The next step is to form a new Socialist government, which owns all industry and all businesses, therefore is the only employer. The third and final step is communism, which as we have seen in Xi, Putin and Khamenei, are horrendous, murdering, Hitler like, dictatorships that are maintained through fear and tyranny.<sup>232</sup>

worth of property damage in Berkeley.<sup>236</sup>

- On August 27, 2017, black-clad Antifa protestors viciously attacked a rally, including targeting at least one person because of his conservative political beliefs. These protests resulted in 13 arrests on a range of charges, including assault with a deadly weapon and obstructing a police officer.<sup>237</sup>
- In June 2018, a Twitter account linked to Antifa shared the names of more than 1,500 Immigration and Customs Enforcement employees, leading others to track and publicly post some employees' social media profiles, phone numbers, and home addresses, which, as intended, resulted in the employees being harassed.<sup>238</sup>
- On June 29, 2019, individuals affiliated with Antifa physically attacked conservative journalist Andy Ngo while he was covering demonstrations in Portland, Oregon, leaving him hospitalized.<sup>239</sup>
- On August 4, 2019, 24-year-old Connor Betts, an ANTIFA supporter dressed in black and clad in body armor, walked into Ned Peppers Grill in Dayton, Ohio and opened fire with a .223 caliber long gun. He murdered 9 people, including his sister, and injured 27 others.<sup>240</sup>
- On May 31, 2020, President Trump announces that he will designate ANTIFA as a terrorist organization.<sup>241</sup>
- In late September of 2020, individuals in a moving truck distributed riot equipment — including shields, masks, and a sign emblazoned with an Antifa symbol — in Louisville, Kentucky, before riots ensued there. Hours later, the violent situation resulted in the shooting of two police officers.<sup>242</sup>
- On October 5, 2020, reported Antifa activists in Portland were captured on video attacking a woman carrying an American flag.<sup>243</sup>
- On January 5, 2021, the White House Press Secretary announced that President Trump will not allow Antifa, or any terrorist organization, to destroy our great country. Federal

officials are to assess actions of ANTIFA activists in light of Federal laws.<sup>244</sup>

- On January 4, 2021, President Trump ordered 10,000 troops from the National Guard to be activated to defend D.C.. The Pentagon refused.<sup>245</sup>
- January 6th was a large ANTIFA setup of Trump supporters.

On December 12, 2020 at a Supreme Court rally, the ANTIFA were not allowed to come near the peaceful protestors thanks to the 300 peaceful Proud Boys.



Here is a picture of a few of the Proud Boys holding a banner on December 12, 2020. This is what the Proud Boys and their wives look like. There were about 200 of them, both husbands and their wives always together. On December 12, 2020, the Proud Boys in this picture were all chanting and marching on the roads circling the Freedom Plaza. They were true, peaceful, law-abiding, patriots as the banner shows. **The ANTIFA were also there wearing helmets and hiding their faces.** The Proud Boys and their wives do not wear masks and helmets at our rallies.

**At the January 6th peaceful protest in DC. It was a true, planned setup to entrap Trump supporters.** I spent the entire morning at the Northeast Corner of the Capitol Building while others were at the Ellipse listening to President Trump's speech.

**The following picture shows clearly the bicycle racks acting as the only barrier between the peaceful protestors and the Capitol Building.** Only the press were allowed in a tiny fenced off area on the other side of the bicycle racks. All Trump supporters respected the barriers and were law abiding.



During President Trump's speech, on January 6th, 2021, there were about 25 men dressed in full camouflage, helmets and masks at the Capitol Building where I was. I saw them march around the Capitol Building three times, chanting. They were mimicking the Proud Boys from December 12th. **They were not the Proud Boys, who always included their wives. The Proud Boys and their wives were all incognito and were mixed in the crowd on January 6th. These were ANTIFA mimicking the Proud Boys from the December 12th protest.**

I listened to President Trump's speech on my phone. Within minutes of President Trump finishing his peaceful address, the people started walking toward the Capitol Building. When the



people were about halfway to the Capitol Building, the ANTIFA committed their crimes. **I was about 50 feet away from the ANTIFA when they marched across the barriers, chanting, and following a black government suburban. The criminal ANTIFA systematically, and illegally, turned over all of the bicycle rack barriers.** It was a setup. Without the bicycle rack barriers, the Trump supporters thought they could legally go onto the Capitol Building steps.

President Trump signed Executive Order 13950, on September 22, 2020.<sup>246</sup> It was titled *Combating Race and Sex Stereotyping*. This executive order states that all men are created equal. It also cuts off federal funding to anyone who teaches race hatred in government institutions.

**“Executive departments and agencies (agencies), our Uniformed Services, Federal contractors, and Federal grant recipients should, of course, continue to foster environments devoid of hostility grounded in race, sex, and other federally protected characteristics. Training employees to create an inclusive workplace is appropriate and beneficial. The Federal Government is, and must always be, committed to the fair and equal treatment of all individuals before the law.”**

**Biden, on his first day of acting presidency, revoked President Trump’s Executive Order. Biden did this with a new executive order number 13985.<sup>247</sup> This order allows federal funding to go to anyone who teaches race hatred, sex hatred or other forms of hate trainings. Critical Race Theory (CRT) teaches race hatred and sexual divisive hatred. Books teaching race hatred and sexual divisive hatred are now promoted in our schools through federal grants.**
